Terms and Conditions of Options

1. Entitlement

Each Option entitles the holder to subscribe for one Share upon exercise of each Option.

2. Issue Price of the Options

The Options are issued for no cash consideration.

3. Exercise Price

The Exercise Price payable upon exercise of each Option is a 45% premium to the volume weighted average of the prices at which Shares were traded on the ASX during the 5 trading day period ending on the business day immediately prior to the date of this letter (**5 Day VWAP**).

The 5 Day VWAP is \$0.8804, and accordingly the Exercise Price of each Option will be \$1.28.

4. Vesting Conditions

33,334 Options will vest 12 months after the date of grant of the options (subject to Ms Gupta remaining employed by the Company continuously from the date of grant up until that date).

Thereafter, 2,777 Options will vest on the 15th day of every month for the first 23 months after 1 year anniversary of the grant of the Options and the remaining 2,795 Options will vest on the 15th day of the 24th month after the 1 year anniversary of the grant of the Options.

5. Expiry Date

6. Ceasing to be an Employee

If at any time prior to the Expiry Date of any Options, an Employee ceases to be an Employee as a Good Leaver, the Employee, will be entitled to keep any Options for which the relevant Vesting Date has passed (**Vested Options**) and the Board, in its absolute discretion, shall determine the amount of any Options for which the relevant Vesting Date has not passed (**Unvested Options**) to vest.

If at any time prior to the Expiry Date of any Options, an Employee ceases to be an Employee as a Bad Leaver:

- (a) in respect of any Vested Options held, such Employee will have until the earlier of:
 - (i) three months from the date of ceasing to be an Employee; or
 - (ii) the Expiry Date of the Options,to exercise the Options, otherwise the Options will automatically lapse; and
- (b) any Unvested Options will automatically lapse.

7. Change in Control

The Options may be exercised by notice in writing to the Company (**Notice of Exercise**) and payment of the Exercise Price for each Option being exercised or, an election to use the Cashless Exercise Facility (as defined below) in respect of each Option being exercised. Any

Notice of Exercise of an Option received by the Company will be deemed to be a notice of the exercise of that Option as at the date of receipt.

10. Cashless Exercise Facility

- (a) The holder of Options may, subject to item 10(c) below, elect to pay the Exercise Price for an Option by setting off the exercise price against the number of Shares which they are entitled to receive upon exercise (**Cashless Exercise Facility**). By using the Cashless Exercise Facility, the holder will receive Shares to the value of the surplus after the Exercise Price has been set off.

- (c) do all such acts matters and things to obtain the grant of official quotation of the Share on ASX no later than 5 Business Days after issuing the Share.

14. Participation in new issues

There are no participation rights or entitlements inherent in the Options and holders will not be entitled to participate in new issues of capital offered to Shareholders during the currency of the Options.

15. Adjustment for bonus issues of Shares

If the Company makes a bonus issue of Shares or other securities to existing Shareholders (other than an issue in lieu or in satisfaction of dividends or by way of dividend reinvestment):

- (a) the number of Shares which must be issued on the exercise of an Option will be increased by the number of Shares which the option holder would have received if the option holder had exercised the Option before the record date for the bonus issue; and
- (b) no change will be made to the Exercise Price.

16. Adjustment for rights issue

If the Company makes an issue of Shares pro rata to existing Shareholders there will be no adjustment of the Exercise Price of an Option.

17. Adjustments for reorganisation

If there is any reorganisation of the issued share capital of the Company, the rights of the option holder may be varied to comply with the Listing Rules which apply to a reorganisation of capital at the time of the reorganisation.

18. Quotation of Options

No application for quotation of the Options will be made by the Company.

19. Options not transferable

Options are not transferable unless they are Vested Options and only with the prior written approval of the Board of directors of the Company and subject to compliance with the Corporations Act.
